1.	IT Officer welcomed the vendors to the pre bid conference. The Project Manager briefed about the the project and invited the queries from the present vendors.
2.	The scope of integration with existing application was discussed.
3.	The vendors requested to provide the e existing COC hardware structure/ specification
4.	Vendor suggested to consider the background of the implementation partner, experience in project completion etc instead of CMMi Llevel 5 certification
5.	The vendors sought relaxation on penalty clause mentioned in Section 7.6.5 of RFP
6.	The vendors suggested to reconsider the payment schedule mentioned in Section 6.1 of RFP
7.	Request for extending the date to raise the queries on RFP(till 14 th Sept, 5:00 pm)
8.	Request for tender documents(RFP and FRS) to be made available for vendors and the payment shall be done while they submit the bid
9.	Vendor suggested that the process flow in the FRS is linked with local practices rather than practices mentioned vide Kerala Municipal Act and also not in line with Citizen's Charter
10.	Request to extend the date for submission of Queries on FRS
11.	Acknowledgement to be sent for all queries received
12.	COC confirmed that the Non IT infrastructure at Janasevanakendra will be provided by them
13.	COC confirmed KSWAN connectivity to main, zonal and circle offices prior to the implementation of the application.
14.	Concern was raised on responding to the FRS in case of specific module(s) required to be developed afresh for COC, with regard to marking the requirement as "Not Available" or "Customizable or Third Party" in the response to RFP.

15. The eligibility criteria " The projects should have been done in multiple site locations, preferably Indian Municipalities" as per the RFP requires to be elaborated on the type and number of projects/ modules which will be considered as relevant for the evaluation of this RFP
16. The vendors suggested that the technical score of 75 for qualifying the evaluation is to be reconsidered as there exist a big gap between 75 and 100 and consideration for a QCBS based evaluation


